RESPONSIBILITIES: Under the direction of the Program Coordinator, and utilizing the framework provided by the program outcomes and the curriculum plan of the practical

nursing program:

1. Effectively facilitates student learning in the classroom, lab, and clinical areas.

- a. Develops instructional plans consistent with program and course outcomes.
- b. Utilizes the current National Council of State Boards of Nursing (NCSBN) Test Plan to guide course nursing content in courses and exams.
- c. Clearly communicates class/clinical expectations to students.
- d. Guides the learning process toward the achievement of established district curriculum goals, establishes and communicates clear objectives to the students for all lessons, units, labs, and projects.
- e. Utilizes a variety of active teaching/learning strategies to enhance classroom and clinical learning.
- f. Prepares client assignments in clinical that challenge students to meet behavioral outcomes.
- Collaborates with other faculty to develop evidence-based evaluation methods for academic courses.
- h. Maintains student and program records.
- i. Collaborates with full time faculty to research and update curriculum, course outlines, manuals, media and other pertinent material on an annual schedule.
- 2. Provides ongoing student support.
 - a. Acts as an advisor to students.
 - b. Demonstrates a commitment to educating a diverse population of students.
 - c. Aids students having difficulty achieving course outcomes.
 - d. Maintains office hours according to Blue Hills Education Association (BHEA) Collective Bargaining Agreement.
 - e. Serves as a professional role model to students.
 - f. Supervises student theoretical and clinical experiences.
 - g. Provides daily feedback to students in clinical as to their progress towards clinical behavioral outcomes.
 - h. Communicates student progress or concerns to other faculty and program coordinator on an ongoing basis.
- 3. Supports the achievement of program outcomes.

In collaboration with program coordinator and other full-time faculty:

a. Develops and implements the philosophy, conceptual framework, and

- outcomes of the program.
- b. Participates in the review and revision of program policies.
- c. Participates in the systematic evaluation and improvement of the program.
- d. Participates in meetings and committees as assigned.
- e. Participates in accreditation activities.
- 4. Participate in the governance of Blue Hills Regional Technical School for the accomplishment of the goals of the school. Serve on committees as assigned.
- 5. Participates in professional development to improve skills in nursing and teaching.
- 6. Other duties as assigned.
