Governor signs transgender public accommodations bill

On Friday, July 8 Governor Baker signed into law legislation protecting transgender people from discrimination, less than a day after he received the comprise legislation approved by both House and Senate the prior day. The law bans discrimination based on gender identity in places of public accommodations and would also transgender people to use sexsegregated facilities such as locker rooms and bathrooms that correspond to their gender identity (not necessarily their birth gender).

The bill directs the MA Commission Against Discrimination to adopt policies on enforcing the law and also requires the Attorney General's office to provide guidance on how to handle legal action if any person were to assert gender identity for an improper purpose. Both offices have until September 1 to report their recommendations, with the law taking full effect on October 1.

MASC will provide further updates to members on the implications for school districts.

SJC pulls Common Core from November ballot

In a unanimous July 1 ruling, the Supreme Judicial Court struck down an attempt to revoke the use of the Common Core classroom standards by putting the issue to the voters on the November ballot. In reaching its decision, the Court did not consider the merits of Common Core. But in scrutinizing the legal language, the court feared the multipart question would have put voters in the "untenable position" of deciding "two separate public policy issues" with a single yes-no vote.

The ruling came just days before the anti-Common Core group — which says it has collected 130,000 signatures since last year — was poised to clear the eighth and final hurdle to qualify for the ballot.

But Common Core supporters — a collection initially of 10 people, with help from the law firm Foley Hoag and the Massachusetts Business Alliance for Education — intervened, challenging the attorney general's approval of the question's legal language.

The proposed question had called for: rescinding the state Board of Elementary and Secondary Education's 2010 vote to adopt Common Core; restoring previous Massachusetts curriculum standards; establishing a new process for developing future frameworks; and annually publishing the questions and answers from the previous year's assessment tests.

The high court found that while those issues might be related, they fail to meet the constitutional standard for "coherence." And publishing the tests, it said, would force the state to invest in creating new tests for each grade and subject each year — a taxpayer expense not hinted at in the question's wording.

SEL and Equity/Poverty Concerns lead Joint Conference Agenda

He was one of the first scholars to bring widespread attention to the consequences - academic, moral, and economic – of educational inequity. More recently, Ferguson has widened his scope of inquiry, developing a broad vision for correcting inequities that centers less on the differences between groups and more on raising the bar for all students. Ferguson is the founder of the Tripod Project for school improvement and faculty director of

the Achievement Gap Initiative (AGI) at Harvard. He has consulted with a number of MA school districts and will discuss some of his findings during his presentation.

As yet another aspect of MASC's commitment to bringing focus to the challenges of equity and poverty, members of the MASC leadership team participated June 11-14 in an Equity/Advocacy program in Washington DC presented by the National School Boards Association. The Saturday Symposium on effective policy and strategies to address equity included sessions on meeting the needs of diverse student populations; defining educational equity in the digital age; fostering healthy, safe and supportive learning environments for all students; and strategies for leveraging funding streams and community resources to help close the achievement gap. The day-long Symposium was followed by NSBA's annual Federal Relations Network/ Advocacy program, at which attendees heard from key legislators on the recently enacted ESSA legislation and MASC attendees met with members of the MA Congressional delegation with whom they discussed issues around school funding, vocational education, student mobility and poverty, school safety, inter-generational issues and concerns about over-regulation.
